#### **Role Purpose**

The Counsellor will provide targeted trauma-informed, culturally appropriate counselling services to support Indigenous Australians with disability, their families and carers that are affected by the Royal Commission.

The roles of the targeted counselling service are to:

- build capacity in the delivery of trauma informed counselling services specifically tailored for people with disability, including those with more complex needs;
- provide access to interpreting or cultural translation services as required;
- provide supportive referrals to legal support services, advocates, financial support services, counselling and psychological care providers;
- refer to or collaborate with appropriate services to provide social and practical support to clients such as housing, health, mental health, financial and aged care services in order to meet the critical needs of the individual;
- accept referrals from the Royal Commission and other Australian Government funded Royal Commission support services, such as the national telephone counselling and referral service, as well as supporting clients that directly approach the service; and

Yorgum will primarily deliver services to Aboriginal and Torres Strait Islander peoples, and will work with other services to ensure a seamless referral for non-Indigenous clients that will access the service.



The service will operate throughout Western Australia (except for the Kimberley) and will have counsellors based in Port Hedland, Kalgoorlie and Perth and will operate Monday to Friday during regular business hours.

#### **Duties and Responsibilities**

#### Counselling

- Conduct initial assessments of individual and/or family needs.
- Provide culturally appropriate, trauma informed counselling appropriate for people with disability, including those with more complex needs.
- Maintain an appropriate client caseload.
- Refer to or collaborate with appropriate services (housing, health, mental health, financial, aged care services) to provide social and practical support to clients to meet individual critical needs.
- Provide access to interpreting services as required.
- Undertake supervision.
- Undertake travel to provide counselling a service to the clients and their families.

#### Administration

- Attend and participate in team and staff meetings.
- Support and participate in evaluation processes as required.
- Contribute to the development and implementation of team action plans.
- Write, enter and maintain client information and case notes on team database.

#### Other

- Participate in Yorgum cultural events.
- Contribute to and implement continuous improvement strategies.
- Contribute to the maintenance of a safe workplace.
- Other duties as required.
- Undertake travel and stay overnight.

#### **Key Performance Indicators**

- Maintain a client caseload as determined by the Manager.
- Keep current and accurate case notes and client records.
- Develop an agreed staff development plan and undergo at least one documented annual performance review.
