

## Cultural Responsiveness Training Program prices:

- **Level One** – Start with Cultural Awareness – self-paced online learning
- **Level Two** – Unpacking the Culturally Responsive Framework – self paced online learning
- **Level Three** – Putting it all into Action - Workshop – Facilitator led -online workshop

### Meaning:

**Self paced online learning** - This course has been recorded and available from an online platform that participants can access in their own time with self-paced material. Accessible anywhere that has internet, and a certificate of completion is delivered afterwards.

**Online workshop** – Participants register for a live hosted interactive Zoom workshop with Indigenous Facilitators. This session is NOT recorded and requires the participant to engage using an interactive online workbook to complete successfully. Public dates are available for individuals to book, or an organization can book a date as a group. – A small homework element is required to be awarded a certificate of completion. (Level 1 & 2 are pre-requisites to this workshop).

**Level One** – can be purchased as a standalone Cultural Awareness course.

**Level One & Two** – can be purchased as a program to be delivered online or licensed as a SCORM file if the organisation has its own LMS.

**Level One, Two & Three** can be purchased as a complete package however level three cannot be done without the completion of level 1 & 2.

**Licensing** – for organisations who have their own LMS system and a large number of participants requiring training, a SCORM file is available for unlimited licensing arrangements.

### Timeframes:

**Level One:** - approx. 3-4 hours from start to finish. There is a short True or False quiz at the end of level one which is required before the certificate is emailed directly to the participant.

**Level Two:** - approx. 5–6 hours from start to finish if you complete all the reflection activities.

Unless otherwise arranged each participant has 90 days to complete level one and level two. In saying this, should the organisation purchase the level 3 as part of the program, the date set for the level 3 workshop will determine how quickly level 1 & level 2 need to be completed as a pre-requisite.

**Level Three** – workshop runs for 3.5 hours (including small breaks) - if the program has been arranged by an organisation, a date can be set for the level 3 workshop on the IAHA training schedule whereby all participants must have completed level 1 & 2 to attend. Anyone who is unable to attend this pre-arranged date can reschedule to attend any of the public level 3 sessions that are on the IAHA training calendar. Alternatively, the organisation can simply provide the public dates for all participants to attend as it suits them within their diary. (workshop is NOT recorded).

**Logistics:**

Each organisation will be set up as an individual group within the learning portal that will allow you to enroll your participants into the course yourself and have full access to the progress of your staff and their details. You can assign yourself or other staff members to be group administrators of your organisation and have full control of the course platform for the duration of the program. Completion or progress reports are also available upon request.

**Face to Face Workshop conditions:**

We would like to offer face to face workshops at some stage in the future, however given the current circumstances of COVID, there is a high risk of cancellation rate. This becomes time consuming & costly to plan an event that is then cancelled. Whilst the material is the same between the online and face to face - there is still a difference in the planning stages, logistics, travel requirements and delivery. This would mean that extra costs are needed to facilitate face to face bookings.

Should you wish to proceed with the planning of a face-to-face workshop we would require a deposit of \$500.00 to secure the date in the IAHA training schedule, which may or may not be refundable depending on cancellation circumstances. IAHA would also require the organisation to be liable for all monies lost through cancellations of venue bookings and/or travel and accommodation bookings.

**These conditions are only required for face to face workshops, not for the online workshops.**
